



# **Upscope Privacy Statement**

We are Upscope Limited ("Upscope", or "we"), a software company based in the United Kingdom. We provide software that helps companies communicate with their customers visually.

This Privacy Statement applies to processing of personal data on our public websites, including but not limited to, <u>upscope.com</u>, <u>upscope.io</u>, <u>livedocument.com</u>, <u>cobrowsingapi.com</u>, <u>userview.com</u>, and <u>helloscreen.com</u> and any subdomains thereof (together the **"Websites"**).

This Privacy Statement does not apply to processing of personal data by our customers through our software. This document is intended to inform you, as a user of our Websites, about which personal data we collect, and how we use this data and why.

### Data we collect

#### We collect the following personal data:

- Your email address, if you provide it. When you provide your email
  address in order to subscribe to our newsletter, you provide consent for
  us to send email newsletters relating to our services. When you provide
  your email address in order to sign up for our free trial we might reach
  out to help you to complete the process.
- Conversations you have with our staff through the chat functionality on some of our Websites. We use this to assist you in the use of the Websites or our services. We do this on the basis of our legitimate business interests, specifically informing you about the functionality of our software and/or selling our software to you. The chat functionality is provided by Intercom Inc., which is based in the United States of America, and adheres to the EU-U.S. Privacy Shield Framework.

We will keep your personal data only for the period necessary to fulfil the purposes for which it was collected or processed, unless we have to keep it for legitimate business, tax or legal purposes. For newsletter subscribers, this means we store your email address until you withdraw consent by unsubscribing, which can be done at any time.

We will not share your personal data with third parties unless it is needed in order to provide the requested service to you, or when we have a legal obligation to do so. Any third parties will process your personal data in conformance with this statement.

#### You have the right to obtain from us:

• information about how we process your personal data, as well as a copy of the personal data which we have stored about you.



 You also have the right to correct, update, shield or delete your personal data in our records, as well as data portability of your personal data to a third party, and to report any misuse of your personal data.

### **Cookies**

Cookies are text files that are set by our Website(s) into the browser on your computer or mobile device. The next time you visit, those cookies allow us to recognise your device. We use cookies across our Websites mostly for analytical reasons: to analyse visitor behaviour (e.g. which pages are viewed often) in order to optimise the usability of the Websites.

We make use of the following third party tools which use cookies. We use Google Tag Manager to implement third party tools. We use the Facebook pixel, Twitter pixel, LinkedIn pixel and Google AdWords Remarketing pixel in order to measure conversion of our advertisements on social media. For general website analytics we use Google Analytics. We use YouTube and Vimeo to display product videos. The chat functionality is provided by Intercom and uses functional cookies to remember earlier conversations. Our Help Center articles are served by Intercom.

how to remove cookies of specific parties and for further information on cookies.

# Third party disclosure

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information.
